



STALLS/VENDORS - GENERAL TERMS AND CONDITIONS

1.1 Closing Date

Applications must be submitted on or before 31 May 2018.

1.2 Placings

Preliminary placings are done as we receive the applications, but Piekfijn Food and Wine has the right to move any stall in the interest of the festival. Successful applicants will be informed via email by 22 June 2018. Vendors are not allowed to change placings amongst each other.

1.3 Evaluation

Applications must include photos and a complete description and listing of products/items. Preference will be given to hand made/manufactured items which reflects creativity and fits the theme of the market. The decision of the management committee is final and no correspondence will be entered into. Previous participation in this event does not automatically approve your application.

Food stalls must adhere to the local municipality's regulations with regards to fire and health. All trading certificates, special permission, permits, health certificates, etc is the responsibility of the vendor.

Food stalls must provide their own fire extinguishers as well as cold storage for perishable foods. Stalls are limited to the specific items awarded to them. Please stick to the items/products awarded to you to limit duplication as far as possible.

1.4 Payment

Successful applicants will receive an invoice and must pay the amount due on or before 30 June 2018. If you cancel after the selection process, a cancellation fee of 50% will be applicable. If you cancel after 31 July 2018, all money paid will be forfeited. You will be liable for the payment of the full invoice. PLEASE NOTE THAT YOU WILL BE LIABLE FOR THE PAYMENT OF THE INVOICE WHEN YOU DO NOT PITCH ON FESTIVAL DAY.

Please indicate your reference number (Piekfijn + Trading Name) on the deposit slip / eft payment email to events@greycorporate.co.za. No cheques will be accepted.

1.5 Operation Hours

The festival is takes place on one day only. Saturday 8 September 2018. The Festival hours are as follows: Saturday – 10:00 to 22:00. Vendors must be set up ready for trade one hour before the start of the festival. Vendors are not allowed to pack up before 18:00. Stalls must be open from 10:00 to 18:00. Should you have an outside stall, you are welcome to stay until the end. Stalls inside the wine tasting area will close at 18:00.

1.6 Logos

The use of the Piekfijn Food and Wine logo or the Piekfijn Food and Wine name on any of the vendor products, without the necessary approval from the management committee is strictly prohibited. Applications can be sent to events@greycorporate.co.za

1.7 Security

Piekfijn Food and Wine provides security for the festival infrastructure, but cannot be held responsible for any damages or losses whatsoever. You are responsible for your stall at all times.

1.8 Accommodation

Vendors are responsible for their own travel and accommodation arrangement as well as the cost thereof. For assistance in this regard or suggestions wrt guesthouses, etc. - contact Lindi on 082 994 7315 or email events@greycorporate.co.za.

No-one will be allowed to overnight on the terrain. Please make the necessary arrangements for accommodation if needed.

1.9 Registration

PLEASE TAKE NOTE: All vendors must register their stalls on Friday, 7 September at Bergsig Academy in order to receive access and vehicle permits. **Registration will take place from 12:00 to 18:00 on Friday, 7 September 2018.** NO permits will be handed out on the morning of 8 September. 1.10 Beverages

NO stalls are allowed to sell beverages or alcohol unless agreed otherwise. All cold drink sales will be done through the cash bar.

1.11 General

No pets are allowed.

Vendors are responsible to keep their stalls neat and hygienic at all times.

Right of admission reserved – Piekfijn Food and Wine has the right to expel vendors for any misbehavior, e.g. loud music, unauthorized use of electricity, etc.

No subletting are allowed.

Some stalls have electricity as and where arranged in advanced at R250.00 per power point.

Please ensure you have your own extensions – minimum of 20metres.

No 3phase electricity will be provided unless arranged in advance.

Please note: Due to the Eskom load shedding schedules, electricity cannot be guaranteed for the duration of the Market. We do however have a generator, but should there be a problem with the generator whatsoever, Piekfijn food and wine will not be held responsible for any damages or losses as a result of load shedding.

Please take note: We have 15 sites available where we will allow generators. We will place these on a first come first serve basis. These sites will only be for FOOD stalls. You are still responsible to bring your OWN GENERATOR.

YOU WILL NOT BE ALLOWED TO BRING A GENERATOR IF YOUR APPLICATION FOR A GENERATOR SITE WAS NOT APPROVED.

Food stalls must make use of gas or open fires for cooking purposes.

Vendors are responsible to supply their own extension cables. Extension cables to be in a good condition.

Vendors are responsible for their own tables, chairs, gazebo's etc.

Vendors must man their stalls for the duration of the event – no exceptions.

Vendors are responsible for the assembly of their own stall. Please stay within the space provided.

Vendors are responsible for dustbins, garbage bags and the overall neatness of their stall.

Vendors are only allowed to sell from their stall and are not allowed to walk around the market area and sell.

No toy guns with bullets or fire-works are allowed to be sold.

NO smoking allowed at the stall areas – only at the dedicated smoking areas.

Piekfijn Food and Wine will not take any responsibility for items/products not sold and does not provide any guarantee for sales.

1.12 Stalls

Stalls vary in size (available upon request) and does not include any frame work. Trailers must form part of stall or must be removed after setup to dedicated parking area. Electricity are available on request at R250.00. Please make the necessary arrangements. Gas is preferable. Please ensure you have everything you need to set up your stall including gazebo's, tables, chairs, table cloths, etc.

1.13 Other Stalls

This will be decided on by the Management.

1.14 Entrance Tickets

Vendors will be issued with two standard adult entry tickets per stand/stall. NO ADDITIONAL TICKETS WILL BE ISSUED FREE OF CHARGE. You are welcome to buy additional tickets at the standard festival ticket price online. You will also be issued with ONE vehicle entry permit per stall.
